From the first day of classes up until 1/3 of the way through the semester, under the tuition and misc. fee system, 2/3 of the total tuition and all other fees will be refunded; under the course credit tuition and misc. fee system, 2/3 of the base amount for tuition and misc. fees (or course credit tuition and misc. fees), the full amount for the course credit fees and Refund the full amount for other fees will be refunded. Calculation 3. More than 1/3 but less than 2/3 of the way through the semester starting from the first day of classes, under the tuition Method and misc. fee system, 1/3 of the total tuition and all other fees will be refunded; under the course credit tuition and misc. fee system, 1/3 of the base amount for tuition and misc. fees (or course credit tuition and misc. fees), the full amount for the course credit fees and the full amount for other fees will be refunded. 4. After 2/3 of the way through the semester starting from the first day of classes, students who suspend or withdraw from their courses will not be granted a refund for the payments they have made. 5. Student who withdraw from school can apply for student group insurance's fee refund according to the regulation of insurance company. 6. The standards for refunds will be calculated based on the date on which the student actually leaves school.
